1.2.1 iOS Authenticator doesn't work with AAF 5.1.3-190

This hotfix resolves an issue where the NetIQ Advanced Authentication app on iOS could not be used for authentication using the Out-Of-Band method in NetIQ Advanced Authentication Framework 5.1.3 build 190. (Bug 940104)

This hotfix requires an existing installation of NetIQ Advanced Authentication Framework 5.1.3-190.
