This hotfix resolves specific previous issues and outlines why you should install this hotfix. Many improvements are made in direct response to suggestions from our customers. We thank you for your time and valuable input.

1 What's New?

The following sections outline the key features and functions provided by this version, as well as issues resolved in this release.

1.1 Operating System Updates

This hotfix for Advanced Authentication Framework includes various operating system updates.

1.2 Enhancements and Software Fixes

Advanced Authentication Framework includes the following software fixes.

1.2.1 RADIUS logfiles contain insecure information

This hotfix resolves an issue where there could be insecure information in the RADIUS logs on the appliance. This information was visible to only those users logged in as an Administrator.

1.2.2 YubiKey CSV import

This hotfix resolves an issue with the import of YubiKey CSV files. Before this hotfix the token ID from a YubiKey was not imported and prevented authentication using YubiKeys.

1.2.3 Unnecessary HEX check on YubiKey Token ID

This hotfix resolves an issue where the Authentication Framework did an unnecessary HEX check on the YubiKey token ID. This check was unnecessary since this is in MODHEX format.

1.2.4 Removed upper limit for HOTP counter window

This hotfix resolves an issue where there was an upper limit of 100 steps for the HOTP counter window. The upper limit has been removed.

2 System Requirements

This hotfix requires an existing installation of NetlQ Advanced Authentication Framework 5.1.3-263.
